4. Sealed or electronic bids must be submitted to the office through PPMO website www.bolpatra.gov.np/egp on or before 12:00 on 2077/08/28. Bids received after this deadline will be rejected.
5. The Online bids will be opened in the presence of Bidders' representatives who choose to attend at 14 :00 hrs, on 2077/08/28 at the office of Rural Municipal Executive. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting as mention above, which shall be valid for 30 days beyond the validity period of the bid .
6. The Bandipur Rural Municipality reserves right to accept or reject, wholly or partly any or all the the bids without assigning reason, whatsoever. Other mandatory information as per PPA and PPR.
